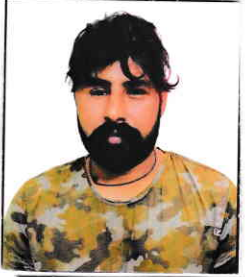

The followings are the aims and objects of the trust:-

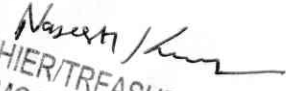
- I. To open, run, start and manage Pre Nursery School (s) and Nursery to 10+2 Classes School (s).

- XIII. To launch cleanliness campaign.

XXIV. To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions.

XXV. To award/issue prizes, medals, certificates, stipends, scholarships etc. to deserving students/participants.

XXVI. To organize educational, historical, geographical, cultural, sports and knowledge tours/travels from time to time.

XXVII. To visit all over India for the attainment of aims and objects of trust.

To do any other acts or things which is ancillary and conducive of any of the above stated objects of the trust.

RETIREMENT OF A TRUSTEE

A trustee generally retires from his office in following circumstances:-

- I. On extinction of trust;
- II. On completion of his duties under the trust;
- III. By resignation or relinquishment of his office; with the consent of Settlor/Founder or President.
- IV. By such means as may be prescribed under the trust-deed;
- V. On being done activities/participating in such activities which are against the aims and objects of the trust;
- VI. Any trustee can be terminated/removed from the trusteeship by the Settlor/Founder or President without issuing any notice.
- VII. On being passed disciplinary action in a special meeting of the trust by the Settlor/Founder or President.

RE-ADMISSION

When the office of the trustee falls vacant due to any reason, a new trustee shall be appointed by the Settlor/Founder or President.

RIGHTS, DUTIES AND RESPONSIBILITIES OF THE TRUSTEES

- I. To elect member(s)/trustee(s) office-bearers of the trust.
- II. To preserve, maintain and develop the movable and immovable properties and funds of the Trust.
- III. To plan, discuss and approve the master budget, annual budgets and periodical budgets.
- IV. To incur any expenses in general and necessary to execute, administer, manage or supervise all the activities of the trust.
- V. To accept donations/grants/subsidies and gifts etc. of any property on behalf of trust.
- VI. To raise loan(s) from any Bank, firm, society, company, industry or financial institutions or Govt. or Semi Govt. Departments, if the need so arises.
- VII. To purchase or take on hire any vehicle for the smooth & well running of the trust.
- VIII. To organize camps, exhibitions, tours, competitions, programmes, seminars, symposiums etc. from time to time.
- IX. To call special meetings for urgent matters.

- X. To make proper arrangement for proper custody, upkeep, repair and maintenance of the properties and assets of the trust.
- XI. The trust has no authority to cut any plot or any colony.
- XII. To appoint auditor(s) and to fix his/their remuneration.
- XIII. The Settlor/Founder or President has full rights to decide the pay of its employees, possesses the right to increase and decrease their wages according to their performance. To appoint and dismiss from service as and when it deems necessary.
- XIV. To visit all over India for disseminate and exchange of views with regard to sports, education, cultural, environmental and health fitness activities etc.

QUORUM & VOTE

All the meetings of the trust, three members will form quorum. All the issues shall be decided by a simple majority of those present at the meeting except the amendments, repealing, alteration or addition in the rules and regulations of the trust.

OPENING A BANK ACCOUNT

The trustees/governing body of the trust should pass a special resolution to open a bank account in the chosen bank and decide who will open and operate the account(s). The bank account should be opened in the name of the trust. The settler/founder or president and Secretary and cashier/treasurer of the trust or any two or three office-bearers will be empowered to open & operate the bank account(s).

DISSOLUTION

- I. That the beneficiaries are a section of public and not specific individuals.
- II. That in the event of dissolution of trust, the funds of the trust will be transferred only to some other trust/Society having similar aims and objectives.
- III. That the funds/properties of the trust will be used only for the objectives of the trust.

AMENDMENTS

Any of the terms of this deed including the trust purposes set out herein may be varied, extended, added or amended from time to time by an instrument in writing. The Settlor/Founder or President and any three members/trustees will be fully empowered to amend the trust deed, if the need so arises.
